He thanked Ms. Cordisco, former Director of Business & Finance, for her efforts in the development of the new collective bargaining unit agreement. Dr. O'Toole thanked the bus drivers and attendants for the difficult and important jobs that they do delivering the children to school safely and ready to learn. He also thanked the association president Mike Gielata for his efforts during the negotiations process. Dr. O'Toole reviewed the initial step and salary increases in the new contract, noting that the association had accepted wage freezes for three of the last six years.
